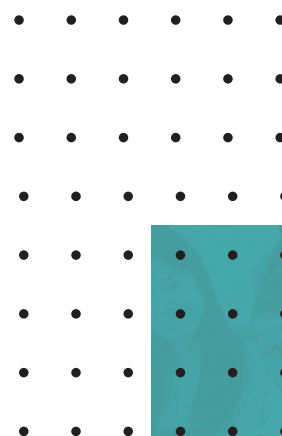

Indonesia continues in improving the quality of human resources (HR) and reduces the unemployment rate by creating competent labors which are ready to compete in the global market through the Japanese apprenticeship program which is a collaboration between the Indonesian and Japanese governments. It aims to provide opportunities for Indonesian youth to learn technology, discipline, work ethic, and high work culture from Japan. As the provider, the job training institution (LPK) has a role important to train and debrief for prospective Japanese apprentices, thus it needs an evaluation program and optimization strategies. Analysis of Chemistry Learning Based on Ethnoscience of Papuan Indigenous People For High Schools in South Papua Province

The Merdeka curriculum in Indonesia aims to build the foundation and character of education through local wisdom to develop student competencies in accordance with characteristic and cultural environment of students. Chemistry learning is closely related to daily life of Papuan indigenous people in Merauke district, South Papua province because their local wisdom contains indigenous sciences related to chemistry which is called ethnoscience as a learning model. Ethnoscience-based chemistry learning can be a solution that makes students easier to understand chemistry material. The aim of this research is to determine the extent to which Papuan ethnoscience-based chemistry learning is implemented in high schools. Method used in this research is descriptive qualitative starting from planning, implementation and evaluation. The results of the research show that ethnoscience-based chemistry learning planning has not been applied to all chemistry topics. The implementation stage, several chemical materials have integrated ethnoscience with local culture, including medicinal plants, local food and ornamental ceremonies, in indigenous people in Merauke district, South Papua Province. At the evaluation stage, it is carried out through student learning outcomes which consist of cognitive assessment, affective and psychomotor skills which overall show good results for sustainable learning in chemistry.

Enhancing Vocabulary Retention Through Cognitive Strategies: The Impact of Wordwall in Virtual Learning Environments

The increasing need to maintain student engagement in digital learning has encouraged researcher into cognitive strategies for effective vocabulary acquisition among young learners. This qualitative study examined the use of Wordwall, an interactive web-based tool, and its influence on vocabulary learning in elementary school students. Through a case study approach, the research explored the cognitive strategies employed by 15 students as they interacted with Wordwall in a non-formal education context. The Findings showed notable improvements in students' vocabulary acquisition, highlighting role of Wordwall in enhancing both vocabulary mastery and intrinsic motivation. Individual student interviews further revealed how Wordwall's interactive design and visual aids facilitated deeper cognitive processing, making learning more engaging and enjoyable. Despite some challenges with complex vocabulary and lengthy questions, the study highlighted the role of Wordwall in fostering deeper cognitive engagement and enhancing vocabulary acquisition through targeted learning strategies. These insights offer valuable implications for integrating digital tools that support cognitive processes in language learning, particularly in improving vocabulary retention and learning outcomes.

Mapping the Themes and Identifying Gaps in DLSZ Research Towards a Comprehensive Research Agenda

The establishment of the De La Salle Santiago Zobel School (DLSZ) Research Office has identified the pillars of the institution's research culture through its initiatives, underscoring the institutional research goals and anchors of the research priorities based on the DLSZ Strategic Plan Framework. As the research culture gradually develops, the growth of research engagement of personnel becomes evident leading to an increase in research outputs. The present study synthesizes 18 research outputs of administrators and faculty members from AY 2021–2022 until AY 2023–2024, at the height of research development required for a capacity-building workshop. Analysis of the studies were conducted in terms of key characteristics and research goals. The findings reveal alignment of the research goals with the DLSZ strategic goals of Academic Excellence, Operational Excellence, and Impact to Society, with a few studies addressing multiple goals. Several common themes associated with the strategic goals emerged, including enhancement of academic outcomes, technology integration in teaching and learning, leadership and professional development for students and educators, and post-pandemic educational adaptations. However, the present study identified the need to explore longitudinal studies, holistic factors integration, and ethical implications in the use of technology, which through prioritization can strengthen the research agenda.

Lasallian Leader in Me: Reinforcing Lasallian Values, School Engagement, and Student Leadership

The Lasallian Leader in Me (LLiM) is a strategic program that is based on the Lasallian Core Values (LCVs) of Spirit of Faith, Zeal for Service and Communion in Mission and 7 Habits of Highly Effective People. De La Salle Santiago Zobel School (DLSZ) embarked on a whole-school transformational process that teaches 21st-century leadership and life skills using the Leader In Me™ framework. DLSZ's Brother Rafael Donato Night High School (BRafeNHS) ran the pilot implementation in AY 2020–2021. This study examined the LLiM program in BRafeNHS and its impact on reinforcing the Lasallian Core Values and enhancing school engagement, specifically on participation in student leadership-related activities from AY 2022–2023. A mixed-method approach was utilized with quantitative data by students' pre-assessment (n1=538) and post assessment (n2=468); faculty (n3=24); and parents (n4=311) derived from the survey results. Qualitative data derived from document analysis and interviews conducted with stakeholders, comprising students (n5=5), faculty members (n6=9), and parents (n7=5) gained a deeper understanding of their experiences with the LLiM implementation. Results provide evidence that the LLiM program has enhanced the Lasallian Core Values, increased school engagement through student leadership activities among the BRafeNHS students.

Referring to a system theoretical framework and utilizing a mixed-methods approach, combining quantitative data from surveys (N=193) and qualitative insights from interviews (N=4), this study investigates the concept of trust in higher education among Danish humanities and social sciences students. The study identifies three distinct dimensions of educational trust. Trust in institutional performance encompasses students' confidence in the knowledge and teaching they receive and its applicability beyond university, while trust in institutional values/symbols pertains to the alignment of university values with student expectations. Trust in fellow students reflects the perceived support and engagement from peers. The study uses cluster analysis to investigate if students within the same university seem to agree on trust or if there are different student groups with varied trust profiles across the three trust dimensions. This analysis reveals four student groups with varying trust levels. One of the groups (28.5% of the students) is characterized by having very high trust across all dimensions, while another (25.4%) is characterized by having high trust. A third group (16.6%) has very high trust in institutional performance and values/symbols, yet only medium trust in fellow students. The last group of students (29.5%) has medium educational trust across all dimensions. We nuance our quantitative findings based on interviews with students that have varied trust profiles in the quantitative study. The interviews illustrate the diverse experiences and perceptions of trust and its antecedents among students, thus highlighting the complexity of trust dynamics in educational settings.

The research reveals that talent development is non-linear and influenced by personal values and motivation, social context, and educational practices.

Key findings show that only a small percentage of participants maintain a consistent interest in STEM, with many shifting to other fields. The study underscores the importance of recognizing and nurturing different types of engagement—behavioral, affective, cognitive, and social—to support the transformation of potential into talent. It highlights the role of pedagogical practices as catalysts for engagement and talent development, advocating for a flexible, supportive, and context-sensitive approach to foster transformative learning experiences.

By integrating theoretical frameworks and empirical data, the presentation proposes a comprehensive model for understanding and enhancing talent development through transformative learning. This model emphasizes the dynamic and complex nature of talent actualization. Referring to the model, we in the presentation suggest educational strategies that adapt to the evolving needs and preferences of talented students.

Thirty (30) Mathematics Teachers were purposively selected through inclusion criteria. The RTPA training-workshop integrated Arduino IDE for programming microcontrollers, Tinkercad, and Creaality for 3D printing technology on mathematics topics such as algebraic expression, arithmetic and geometric sequences, simulator scientific calculator, protractor, measurement, and 3D polygons. The participants answered the proficiency test and in-depth interview after the training. Based on the formulated Mathematical Learning Model, the researcher established an RTPA Theory. Based on the formulated Mathematical Learning Model, the Robotics Technology Pedagogical Approach Theory is an interdisciplinary approach that aims to stimulate curiosity and computational thinking of learners to enhance 21st-century skills, promote higher-order thinking skills, improve problem-solving and mathematical skills, and increase numeracy skills and critical thinking skills in mathematics. Since RTPA activities are interesting, engaging and useful in class, Mathematics teachers can use this approach for hands-on learning, interactive drills and boost mastery, interdisciplinary connections, real-world applications in mathematics and provide authentic assessment. To address this issue, the study proposes a system that merges the advantages of physical books and e-books, introducing the concept of a “Reading Map” where readers can discover books by physically visiting specific locations. This mechanism leverages behaviors and emotions such as pilgrimage and collection-oriented interests, creating a unique reading experience that combines exploration and personal interaction with literature. When visiting designated spots, users gain access to related book information, fostering moments of surprise and inspiration driven by chance. Furthermore, collectable elements are incorporated to maintain long-term reading motivation, while features like visualized maps and collection histories stimulate the user’s intellectual curiosity. Drawing from prior examples such as library systems supporting serendipitous encounters, pilgrimage culture, and the psychology of collecting, this approach diversifies how reading is experienced in contemporary contexts, providing a richer, more immersive and meaningful interaction with books.

Integrating VARK Learning Styles and Eye-Tracking Technology in Dance Education: Insights into Visual Attention and Instructional Strategies

The synergy between VARK learning styles and instructional strategies offers a novel perspective for addressing individualized learning needs. This study investigates the application of eye-tracking technology and VARK learning styles in dance education, focusing on visual attention distribution during movement learning. The students who were pre-service teachers' learning styles were classified using the official VARK questionnaire, and conducted movement instruction based on VARK strategies. Eye-tracking data were collected as participants viewed videos before and after instructional, and follow-up interviews explored their learning experiences. Results showed that among the 11 students, most were multimodal learners (MM), with others classified as strong kinesthetic (SK) and mild kinesthetic (MK); all preferred kinesthetic instructional strategies. Before instruction, MM and SK students primarily relied on textual information processing, while post-instruction, they demonstrated increased attention to images. The MK students maintained a stable preference for both text and images throughout. Sequential analysis further revealed that, before instruction, students' visual attention was initially focused on textual elements, then shifted toward hand and foot movements. After instruction, they displayed improved coordination in visual attention patterns, with more frequent shifts between hand and foot actions. Interview data indicated that students perceived multimodal learning strategies, shifts in focus, repetitive practice, and role-playing as significantly enhancing their dance learning outcomes. The integration of eye-tracking with VARK learning styles not only suggests the need for diverse instructional strategies to accommodate individual learning needs but also provides innovative insights and approaches for future educational practice, with substantial theoretical and practical implications.

In contrast, longer events, such as the 3000 meters, rely more on energy utilization and aerobic endurance, highlighting the importance of efficient energy management over time. The research advocates for concurrent training, which combines strength and aerobic conditioning. This approach is essential for optimizing both physiological and mechanical performance, enabling athletes to sustain high-intensity efforts while reducing fatigue. By incorporating these training methods, athletes can enhance power output and aerobic capacity, both crucial for success in middle-distance events. The findings reveal strong correlations between physical assessments, including strength, speed, and endurance, and actual race performance. This suggests that a balanced combination of these attributes is necessary for optimal performance. While mechanical power is vital in shorter races, endurance and energy management become more important in longer distances. Additionally, the study highlights the value of personalized training programs that cater to an athlete's individual strengths and weaknesses, fostering long-term development and maximizing performance in competitive middle-distance running.

Dynamic Monte Carlo Simulation of Fire Occurrence in Tropical Peatland Using Logistic Regression Approach

Peatland fires significantly impact the ecosystems, climate, and livelihoods of human, necessitating effective predictive models and mitigation strategies. This study develops a dynamic logistic regression model to estimate the probability of fire occurrence based on spatial, temporal, and environmental factors, specifically focusing on key peatland hydrological areas in Indonesia. Static variables in this study are distances to roads, river, coastline, and combine with dynamic variables such as distance to settlement, distance to nearest forest, weather conditions during dry season, landcover, and landuse. The iterative simulation framework integrates annual updates by recalculating distance between mid-point of polygons and critical features, reflecting the impact of landuse change caused by fires. Using this approach, fire probabilities for subsequent years are predicted, enabling the model to adapt dynamically to evolving environmental conditions.

Model performance is evaluated using Dice-Sorensen index, demonstrated high accuracy in replicating historical fire patterns. This iterative methodology highlights the significant influence of proximity to settlements and landuse changes on fire risks. Furthermore, it offers a robust foundation for long term fire prediction and mitigation planning. The finding provides critical insights for sustainable peatland. Future research can enhance this framework by incorporating machine learning technique and high-resolution geospatial data.

Exploring the Role of Artificial Intelligence in Shaping Creativity and Employee Personal Development

The study highlights both the positive and negative aspects of AIC in the workplace. While AI has the potential to enhance creativity and foster individual and collective development, it also introduces new sources of stress. These findings underscore the need for effective training, clear communication, and realistic expectation management. The study concludes that optimizing AI integration in professional environments requires a thorough understanding of its capabilities and limitations to maximize its benefits and address its challenges.

The study investigates the demographics of RSAP's base, their assessment of the organization's performance, and desired future directions. Survey findings reveal a male-dominated (78%) membership base concentrated in the 35–44 age group. Nearly half (46%) of respondents held college degrees. Majority (69%) are employed, which primarily (36%) comes from the food businesses and private institutions. Social media is the primary engagement platform, with high satisfaction expressed towards RSAP's services. RSAP is viewed to have strong leadership, social media presence, and a robust supporter database. Opportunities include services tailored for women riders, harnessing political power, and establishing a Road Safety Academy. Potential threats encompass limited staff and volunteer training, and competition from other motorist-oriented parties.

The study concludes that RSAP plays a significant role in motorcycle riders' and motorists' safety. By addressing its weaknesses and capitalizing on its strengths and opportunities, particularly through formalization, informative publications, and engaging women, RSAP can solidify its leadership position. Fostering collaboration with law enforcement and effectively responding to competition are crucial for long-term success.

This research contributes academically to the understanding of advocacy group effectiveness in the Philippines and offers practical insights for RSAP to enhance its performance and impact.

This study examines the statistical risk ratios of bullying experienced by special needs students in inclusion classrooms, analyzes related research conducted in Turkey and globally, and highlights the academic, psychological, and social impacts of bullying using up-to-date resources. Prevention and intervention strategies against bullying are also summarized, followed by general inferences and recommendations.

Bitterness in Sweetness: A Sustainable Model for The Sugarcane Industry

Sugarcane is one of the important cash crops grown in the Philippines and its products serves as an important raw material and ingredients to various sectors of the economy, especially food processing, fast-moving consumer goods (FMCG) and ethanol companies. This crop is planted throughout the country but is most abundant in the Visayas and particularly on Negros and Panay Islands. The study explored the current state of the sugarcane industry in the fourth (4th) district of Iloilo, Philippines, C.Y. 2023. The findings were used as basis in developing a proposed sustainability model for the sugarcane industry.

This study applied the case study research design in determining the current state of the sugarcane industry in the fourth (4th) district of Iloilo, Philippines, C.Y. 2023, with both primary and secondary data. This focused locale is Passi City, San Enrique, Dingle and Barotac Nuevo. The data about the profile of the sugarcane industry in terms of annual production of sugarcane, land use for cultivation, value of sugarcane industry, number of planters, and number of sugar mills was obtained at the City Agriculture Office (CAO) of Passi City and the Provincial Agriculture Office of the Province of Iloilo, Philippines. The participants of this study were the 12 owners, administrators, and trusted personnel of the sugarcane farms and milling entities. A researcher-made interview guide consisting of three (3) parts, was used to gather primary data. Descriptive statistics was used to analyze the profile of the sugarcane industry, while thematic analysis was used to analyze the data gathered through interviews.

In terms of the profile of the sugarcane industry in the fourth (4th) district of Iloilo, Philippines, the biggest land area that was planted with sugarcane was 12,680 hectares in 2021–2022, the highest quantity of cane that was produced was 797,713 tons in 2018–2019, the raw sugar production in 2021–2022 was 62,227 tons, there were 5,530 hectares of land used for cultivating sugarcane, the highest production of raw sugarcane was 62,227 tons and 56,451,401 kilograms of raw sugar with the value of Php2,709,667,248.00 in 2021–2022 at Php 48.00 per kilo. While for farm size of below five (5) hectares, there were 3,848 farms, comprising of 43.53% of all the farmers, only two (2) sugar mills in the Province of Iloilo, Region 6 in the Philippines. The themes created for the information on the crucial strategies applied by the management of sugarcane farms or haciendas and milling companies in the fourth (4th) district of Iloilo, Philippines are Plowing and Harrowing as Field Preparation, Crop Residue Mulching, Model Farm as Benchmark for Variety Selection, Cuttings as Alternative Planting Material, Weed Control and Fertilizer Application, Bagasse as Feedstock for Biofuel Production, Solid Crop Residue as Organic Fertilizer, and Using Molasses as Source of Vitamins for Farm Animals. The themes created for the information on the external factors that affect the sustainability of the sugarcane industry in the fourth (4th) district of Iloilo, Philippines are: Philippine Policy on Sugar Importation Policies Influenced Market Dynamics, Peso–Dollar Exchange Rate Instability Leading to Higher Input Prices, Skyrocketing Costs of Production, Economic Crisis, and Strong Typhoons and Extreme Heat and Drought. The themes created for the information on how the management of the sugarcane farms and milling companies address issues when arise are Chemical Pesticide for Pest and Disease Control Towards Maintaining Quality Harvest, Proper Pesticide and Herbicide Usage, Neutralizing Soil Acidity with Right Fertilizer Type and Lime Application, Cost Reduction in Response to Fluctuating Sugar Market Prices, Proper Post-Harvest Cane Cleaning and Mechanized Farming. Therefore, the sugarcane industry the production of raw sugar in the 4th district of Iloilo, Philippines shows an upward growth and resilience despite various internal and external challenges, economic, governmental regulations, politics and adverse effects of climate change like strong typhoons and EL Niño.

Using the Responsibility Transfer Teaching Model to Train Primary Caregivers of Children Aged 0–2 with Suspected Autism to Implement Natural Context Teaching Strategies

The study explored the use of natural context teaching strategies by three primary caregivers during snack time at a family support center. While these strategies were effective in this setting, their application in parent-child activities and free play was limited. Home visits revealed that, except for one caregiver, the others struggled to generalize these strategies at home, with infrequent use. Challenges included socioeconomic factors and health issues affecting emotional stability. Despite these difficulties, all caregivers improved their interactive behaviors, becoming more sensitive and responsive to their children. The children's language communication also showed significant enhancement, with increased verbal exchanges and better engagement. Three months post-intervention, only one family continued using the strategies during free play, highlighting the need for tailored approaches considering family diversity. As the children's communication developed, some parents felt less need to create intentional learning opportunities. The findings indicate that early interventions must be adaptable to individual family needs and suggest further research to provide comprehensive support.

The Relationships Among Perceived Parental Overparenting and Perfectionism in High School Students

This study investigates the relationship between parental overparenting and perfectionism among high school students in Nantou County, Taiwan. Utilizing a cluster sampling method, data were collected from 600 high school students, yielding 565 valid responses (94.2% response rate). Among the respondents, there were 245 males and 320 females, comprising 289 first-year, 165 second-year, and 111 third-year students, with 131 being only children. The results indicate a significant positive correlation between parental overparenting and perfectionism, consistent with existing literature. Specifically, heightened parental scrutiny regarding children's academic and personal lives correlates with increased perfectionistic tendencies, while granting autonomy appears to mitigate such tendencies. The social expectation model posits that elevated parental expectations are a fundamental source of children's perfectionism. Overparenting manifests through excessive concern and unrealistic expectations, compelling children to establish high standards while simultaneously engendering fears of failure and mistakes. Furthermore, the findings reveal a significant positive correlation between parental overparenting and psychological control. This relationship suggests that as the degree of overparenting intensifies, so does the level of psychological control exerted over children. Psychological control, characterized by intrusive parenting practices that foster dependency, includes excessive monitoring of academic performance and involvement in extracurricular activities. Moreover, psychological control is significantly correlated with perfectionism, indicating that increased psychological control contributes to the development of perfectionistic traits in children. The study identifies psychological control as a partial mediator between parental overparenting and perfectionism, elucidating the mechanisms underlying these interrelations. Overall, the findings underscore the detrimental impact of excessive parental intervention on children's psychological development, highlighting the necessity for balanced parenting strategies to promote healthy psychological outcomes.

Preliminary Validation of Origami Complexity Using an Information-theoretic Approach

This paper provides a conceptual framework for an innovation model in the makerspace utilizing paper folding, specifically origami. Origami, as a low-cost, safe, and flexible paper folding technique, is chosen for this study due to its versatility across various subjects. The transformation of origami from an art form into an educational tool, research method, and business application is explored in this study to propose a new innovation model. This paper introduces an information-theoretic complexity metric for origami folding, aiming to answer the following questions: 1) How can the difficulty of origami be quantitatively measured using an information-theoretic approach? 2) Can this proposed metric be validated through human-subject studies? Data collected from human-subject studies, via observations, reveal that the proposed computational origami complexity is well validated through a Spearman's correlation test. Additionally, this study examines age and gender differences in origami activities, showing significant differences based on age but no notable difference based on gender. Further research is needed to explore how artificial intelligence and expanded human-subject studies may contribute to innovations in the assessment, prevention, and rehabilitation of mental and developmental disorders, such as ADHD, autism, and dementia.

Iyer examines the hybridization of cultures, capturing moments where Western symbols like Hollywood and fast-food chains transform into aspirational meanings in Asian context. In *Falling Off the Map* he delves into the peculiar sense of isolation and connection found in overlooked or remote parts of the world, offering insights into the universal human desire for meaning and belonging. Similarly, with *Sun After Dark* Iyer ventures into the metaphysical aspects of travel, reflecting on how encounters with unfamiliar cultures can redefine one's inner landscape. The "global village" as conceptualized by Iyer, is not merely a physical phenomenon but a metaphysical home --- a space constructed through shared experiences, carrying within it the converging influences of multiple cultures, shaping the individual a 'mongrel' identity. Iyer vividly captures the paradoxes of globalization, illustrating how cultural markers are simultaneously familiar and foreign. The global village, internalized within individuals, becomes a metaphor for the complexities of contemporary identity --- a harmonious yet discordant blend of individuality and universality.

A Comparison of Evaluative that Clauses in the Abstracts of Nursing Research Articles in International and Japanese Nursing Journals

This study investigates the frequency and forms of four evaluative elements—namely the evaluated entity, evaluative stance, source of evaluation, and evaluative expression—across 300 abstracts published in leading nursing research journals and Japanese nursing journals. The evaluated entity includes authors' appraisal of their own findings, previous studies, research aims, and the methods or theories employed, highlighting underlying notions of purpose, coherence, and value. Evaluative stance is conceptualized as the manner in which authors convey their attitudes through particular predicates, adopting either an attitudinal stance (reflecting affect or obligation) or an epistemic stance (assessing truth or accuracy). The source of evaluation is categorized into three types: human (authors or other researchers), abstract entities (e.g., data, spectrographs, or results), and a concealed origin (e.g., the pronoun "it"). Evaluative expressions can be verbal or non-verbal, with the latter—typically nouns or adjectives—being comparatively rare. Verbal expressions encompass research acts, discourse acts, and cognitive acts. Statistical analyses revealed significant differences in these evaluative strategies between abstracts in prominent nursing research journals and those in Japanese nursing journals. These findings are of particular relevance not only for EFL researchers, but also for novice scholars attending academic conferences for the first time, as well as for EFL instructors specializing in academic writing.

Deep Learning for Colorectal Lesion Segmentation in Colonoscopy Images

Colorectal cancer represents a critical gastrointestinal disorder that poses a serious threat to life and has become a prominent global health issue, with concerning statistics regarding new cases and deaths reported in 2018. In South Korea, there has been a notable rise in colorectal cancer diagnoses over the last five years. A significant number of these cases go undetected due to the intricate nature of colorectal lesions, which presents a challenge even for seasoned healthcare practitioners. This research aims to utilize deep learning, particularly convolutional neural networks (CNNs), to improve the accuracy of colonoscopy image evaluations. The approach taken involved training the CNN model on an extensive dataset and refining it to attain high levels of accuracy in image segmentation. This method facilitates the automatic and precise detection of lesions, which is vital for accurate diagnosis and treatment strategies. The performance of the developed model was assessed both qualitatively and quantitatively using the CVC-ClinicDB dataset, which comprises 612 images. The model achieved a pixel level classification accuracy of 89% accuracy highlights the effectiveness of the deep learning methodology in enhancing colonoscopy image analysis and improving diagnostic results.

It embodies the principle of equal educational opportunities, ensuring that individuals, regardless of gender, can develop their potential fairly without undue restrictions based on gender. According to scholar Banks, gender equality education is not only an ideal but also a reform movement and educational practice. Voorhees emphasizes that gender equality involves giving equal respect to all genders, while Grossman & Grossman advocate for treating everyone equally based on the principle of sameness. This study investigates the effectiveness of gender equality education experimental curriculum for special education classes over a four-month period, comprising thirty lessons. A quasi-experimental design was implemented, featuring an experimental group and a control group, each with 12 students. Based on these results, the study provides specific recommendations for curriculum design and suggests avenues for future research to further enhance gender equality education in special education settings.

Cost Model Development for Green Building Compliance with Indonesia's Regulation No. 21/2021

Regulation of the Minister of Public Works and Public Housing of the Republic of Indonesia Number 21 of 2021 concerning Green Building Performance Assessment in obtaining Building Approval (PBG) and Functional Worthiness Certificate (SLF) is mandatory for buildings, but building stakeholders believe that green building investment costs are expensive. Through Soft System Methodology, which uncovers the problems that occur and then provides recommendations to obtain agreement through an expert panel with content validity index (CVI) analysis and questionnaires, five variables are obtained, namely conventional buildings, green buildings, value engineering, lifecycle cost analysis and cost performance with 26 dimensions, and 92 indicators in obtaining an effective cost model for green buildings processed with SEM Smart-PLS. It was found that the five variables of conventional buildings, green buildings, value engineering, life cycle cost analysis and cost performance influence each other, followed by 26 dimensions and 92 indicators which also have a significant impact and the equation $Y = 0.016 X1 + 0.182 X2 + 0.093 X3 + 0.683$ Lifecycle Cost is the highest influence which states that the initial cost of costs is based on building life cycle costs, green building construction costs only have a small impact on the value of the entire building when compared to non-construction costs. The results of this research will support the implementation of the Regulation of the Minister of Public Works and Public Housing of the Republic of Indonesia Number 21 of 2021 and make developers and property owners not only take into account the initial costs of building green buildings, as well as enable practitioners and academics to benefit from green buildings financially and educationally. , productivity, energy and water resources, and global.

Furthermore, students with learning disabilities exhibit higher rates of behavioral problems, substance abuse, and suicidal risk compared to their peers. Additionally, their self-efficacy and motivation for learning are often perceived as relatively low. Students with learning disabilities are often diagnosed by physicians around the first or second grade of elementary school. They typically exhibit characteristics such as attention deficit, hyperactivity, impulsivity, and difficulties with emotional regulation. As they progress to the upper grades of elementary school, their reckless behavior and manner of expression can lead to interpersonal conflicts, resulting in social exclusion or bullying. This research investigates the impact of multimedia computer-assisted instruction on enhancing bullying awareness among elementary school students with learning disabilities. Utilizing a single-subject research design with multiple probes, the study involved three participants and assessed effectiveness across baseline, intervention, and maintenance phases. Findings revealed that the multimedia instruction not only significantly improved immediate bullying awareness but also maintained its effectiveness over time. These results underscore the potential of technology-enhanced learning in fostering critical social awareness and suggest practical applications for educators.

Study on the Effects of Scaffolding Language Instruction on Language Abilities in Children with Autism

Autism is a severe developmental disorder that manifests in early childhood, characterized by three key features: impairments in social interaction, verbal communication, and a narrow range of repetitive interests and behaviors. Various theories, such as deficits in psychological theory, executive function, joint attention, intentionality, central coherence, and emotional abilities, attempt to explain the core symptoms of autism; however, they do not account for all symptoms. Researchers are also exploring genetic factors, aiming for breakthroughs in treatment and prevention. This research investigates how scaffolding language instruction impacts the language skills of children with autism. Utilizing a single-subject, multi-probe design across various contexts, the study includes generalized probing and interviews as supplementary methods. The subjects comprise ten children with autism from regular kindergartens in Taichung City, Taiwan. They were randomly assigned to experimental and control groups, with five children in each group; however, one child from the control group dropped out due to relocation. The results demonstrate that scaffolding language instruction significantly improves learning outcomes for the experimental group compared to the control group, indicating a notable effectiveness of this teaching method. Interview findings reveal that both teachers and parents recognize the children's capacity to use acquired language skills in daily communication interactions, suggesting that scaffolding language instruction can facilitate meaningful engagement in social situations. Overall, the study highlights the potential benefits of tailored language instruction for young children with autism.

A Case Study on the Communication Functions of Non-Conventional Speech in Autistic Children

Children with autism may engage in several forms of non-conventional language behaviors, including echolalia, where they repeat phrases inappropriately across contexts; immediate and delayed echolalia, where they verbatim repeat words from conversations; scripting, where they recite lines from songs or previous dialogues; and repetitive questioning, where they ask the same questions multiple times. While puzzling, these behaviors represent a primary mode of expression in the early language stages of autistic children, despite not conforming to traditional communication norms. Understanding the communication functions of these behaviors is crucial. Non-conventional language can express needs, facilitate social interactions, and enable participation in exchanges. This study aims to explore the types of non-conventional speech and communication functions in preschool-aged children. The findings reveal that both children primarily use general speech, indicating it as their main mode of expression. Approximately half of their non-conventional speech serves multiple communication functions, predominantly focusing on “maintaining interaction” and “seeking attention.” Echolalia is primarily used for interaction and self-reminders, while metaphorical language encompasses functions such as attention-seeking, commenting, avoiding protests, and expressing emotions. Additionally, repetitive questioning mainly functions to seek attention and request information. The factors influencing non-conventional speech are categorized into internal aspects, such as language ability and emotional regulation, and external elements, including curriculum content and teaching methods. Notably, the emergence of these speech types occurs at different ages, suggesting a developmental progression related to language skills. These insights provide a deeper understanding of communication strategies in high-functioning autistic children and can inform future interventions and educational approaches.

By collaborating with peers, these children can share insights, clarify concepts, and develop their communication skills, ultimately improving their reading comprehension and overall academic performance. The purpose of this study is to analyze the effect of cooperative learning on the reading comprehension abilities of children with hearing impairments. The research employs a single-subject design with alternating treatments to conduct the study. The subjects are two children with hearing impairments, who underwent four self-developed "reading comprehension tests" during the baseline phase. In the intervention comparison phase, they completed fifteen self-developed tests, followed by five tests in the final phase. Physical and Mechanical Properties of Cement-Based Skim Coat utilizing Limestone from Northern Mindanao, Philippines as Filler Material

Cement-based skim coat is a vital material for residential and commercial wall and ceiling applications. Its growing demand can be attributed to the increasing preference for energy-efficient and sustainable construction practices, which prioritize environmentally friendly materials such as paints and coatings. A key ingredient in skim coat production is limestone, commonly used as a filler material. To enhance productivity and cost-effectiveness, efforts have been made to identify locally available sources of limestone. This study investigates the potential of limestone from Northern Mindanao as a filler material in cement-based skim coat production. The limestone was analyzed, and skim coat samples were produced at varying limestone-to-cement ratios, particle sizes, and water demands. The study evaluated the effects of these factors on the ease of mixing, workability, setting time, trimming, adhesion, and compressive strength of the skim coat. Results revealed that the limestone from Northern Mindanao, with a calcium carbonate (CaCO_3) content of 93.3%, is a suitable filler material, as evidenced by the physical properties of the skim coat. Additionally, the samples met the standard specification of compressive strength for skim coat materials. These findings highlight the significant potential of Northern Mindanao limestone in cement-based skim coat production.

Liver and Tumor Segmentation Using Convolution Neural Network

The process of clinical visualization involves the identification and segmentation of liver tumours. This is essential for accurate diagnosing, treatment planning, and disease surveillance. In this study, we investigate and compare three contemporary convolutional neural network (CNN) architectures—U-Net, DenseNet, and ResNet—for liver tumour segmentation in CT scans. Each model was trained and evaluated on a dataset containing annotated liver CT images, concentrating on accuracy, Dice coefficient, Intersection over Union (IoU), precision, and recall metrics. Among the six test samples used for evaluation purposes, U-Net architecture displayed superior overall performance with an average Dice coefficient of 94.4%, IoU of 89.2%, precision of 93.4% as well as recall rate of 95.7%. Average Dice coefficient for DenseNet that uses densely connected convolutional layers was 92.5%, while the IoU was recorded as 86.7%, precision – 91.9% and recall – 94.0%. Deep residual learning framework in ResNet yielded competitive results with median DICE coefficient at 91.4%, IoU at 85.3%, Precision at 90.6% and Recall at 93%.

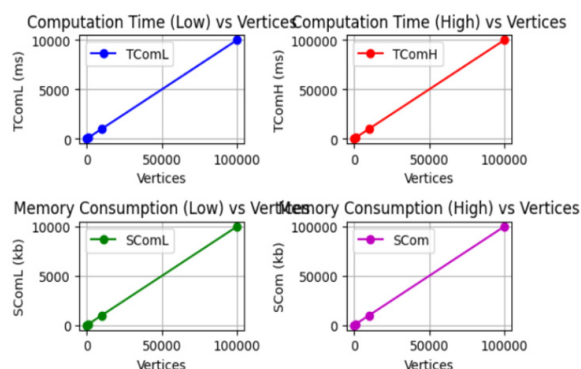

Similarly, the columns "SComL (kb)" and "SCom (kb)" track the memory consumption of the algorithm under low and high complexity conditions. "SComL" shows the memory used for smaller instances of the graph, while "SCom" indicates memory usage for larger, more complex graphs.

PROPOSAL METHOD

Problem Statement

We can minimize the complexity of finding the minimal spanning tree process using the quantum computing approach. The time complexity of Kruskal's algorithm is $O(E \log E)$, where E is the number of edges. Using quantum computing the time complexity of the quantum

approach is exponential in the number of qubits, while the space complexity is linear. The classical approach has a polynomial time complexity and space complexity, $O(2^n)$ and $O(n)$ are the time and space complexities respectively.

Proposal

Quantum computing [11] is a domain within computing that utilizes the concepts of quantum physics to carry out computations that traditional computers cannot handle. In classical computing, information is stored in binary digits, or bits, which can only hold values of 0 or 1. On the other hand, quantum computers use quantum bits, or qubits, which have the ability to exist in several states at once, thanks to a property known as superposition. This capability allows quantum systems to evaluate numerous solutions in parallel. Another crucial feature is entanglement, where qubits [12] become intertwined in such a way that the state of one qubit influences the state of another, even when separated by vast distances.

This interaction can potentially accelerate certain kinds of computations dramatically. Additionally, quantum computers exploit quantum interference, which can strengthen correct solutions and eliminate incorrect ones. Even though quantum computing holds tremendous promise, it is still in its early stages, facing hurdles such as error correction, coherence time, and scalability [14] of hardware. It begins by defining an adjacency matrix representing the graph's structure and initializes a quantum circuit with a sufficient number of qubits. A Hadamard gate is applied to each qubit to create superposition, allowing exploration of multiple states simultaneously. The code then applies controlled-X (CX) gates between qubits based on the edges in the adjacency matrix, entangling the qubits and capturing the graph's connectivity.

After applying quantum operations, the qubits are measured, and the results are compiled and run on a quantum runtime. The measurement outcomes are analyzed as binary strings, each representing a possible configuration of the graph's edges. Finally, the program extracts potential MSTs by checking which measurement outcomes correspond to valid spanning trees and prints these configurations. This process demonstrates a quantum approach to solving graph-related problems, with the potential for speedups in solving complex optimization tasks.

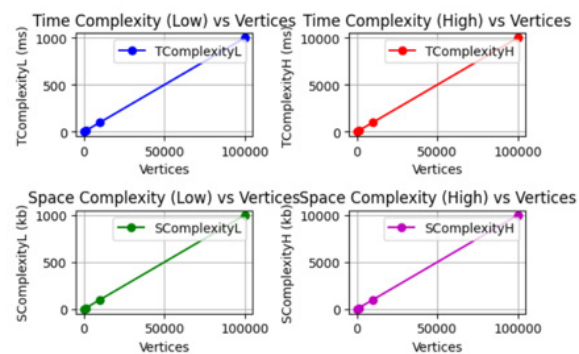

As the number of vertices and edges rises, memory usage increases, with the SComplexityH values growing more drastically, reflecting the higher memory requirements for complex graphs. In summary, the data highlights the scalability challenges of algorithms dealing with large graphs, where both time and space complexity increase as the graph size grows. This illustrates the need for efficient algorithms or computational optimizations, especially for real-world applications where graph sizes can be enormous.

Shor's algorithm: CPU time $\approx 10^6 \times$ Quantum gate time (for a 2048-bit key), Grover's algorithm: CPU time $\approx 10^3 \times$ Quantum gate time (for a database of 10^6 entries), Quantum simulation: CPU time $\approx 10^2 \times$ Quantum gate time (for a simulation of a 10-qubit system)

EVALUATION

The classical and quantum approaches to graph-related problems differ significantly in terms of time and space complexity. For instance, a classical algorithm like Kruskal's for Minimum Spanning Tree (MST) has a time complexity of $O(E \log E)$, where E is the number of edges, and a space complexity of $O(V + E)$, where V is the number of vertices. For a graph with 5 vertices and 7 edges, the classical approach

would require approximately $O(20)$ time and space for 12 elements. In contrast, a quantum algorithm might have a time complexity of $O(2^n)$, where n is the number of vertices, and a space complexity of $O(n)$, requiring space proportional to the number of qubits. For the same graph, the quantum algorithm would take $O(32)$ time and require only 5 qubits, but its exponential time complexity grows quickly with the number of vertices. As the graph size increases, the quantum algorithm's time complexity becomes a challenge, while the classical approach remains more efficient in terms of time for larger graphs. Quantum computing, while offering potential in space efficiency, still faces challenges in practical applications due to its exponential time complexity. Therefore, for most graph problems, classical algorithms are more feasible, though quantum computing holds promise for specific, optimized scenarios in the future.

CONCLUSION

The Minimum Spanning Tree (MST) problem can be solved using both classical and quantum approaches, with varying degrees of efficiency depending on the size of the graph. For small graphs (100 vertices, 1000 edges), the classical approach (e.g., Kruskal's algorithm or Prim's algorithm) is faster and more efficient, with a time complexity of $O(E \log E)$ or $O(E + V \log V)$ and a space complexity of $O(V + E)$. However, as the graph size increases (1000 vertices, 10000 edges; 10000 vertices, 100000 edges; 100000 vertices, 1000000 edges), the quantum approach (e.g., QAOA) becomes more advantageous, with a time complexity of $O(2^n)$ or $O(n^3)$ and a space complexity of $O(n)$, offering a speedup of 10–100 times, 100–1000 times, and 1000–10000 times, respectively, compared to the classical approach. Ultimately, the choice of approach depends on the specific graph size and the available computational resources, with the classical approach suitable for small and medium-sized graphs and the quantum approach more suitable for large and very large graphs, highlighting the potential of quantum computing to efficiently solve complex optimization problems.

Future Work: Please use quantum circuit learning algorithm to learn a quantum circuit that finds a minimum spanning tree of a graph. The circuit is learned by training a quantum neural network on a dataset of graphs and their corresponding minimum spanning trees.

Investigating Cultural Intelligence in English Communication of Multicultural Sport Athletes and Coaches

The study investigated the dimensions and stages of cultural intelligence (CQ) among multicultural athletes and sport coaches when interacting in an English communication context. Based on Kachru's three concentric circles (1985) and the Cultural Intelligence Scale (CIS) questionnaire (Earley & Ang, 2003), 33 participants, including 25 athletes and eight coaches (five from the inner circle, 16 from the outer circle, and 12 from the expanding circle) were asked to complete the CIS questionnaire. The findings for the CQ dimensions indicated that both athletes and coaches showed the highest frequency in Motivational CQ. Among the athletes, Cognitive CQ was the dimension with the lowest frequency, while among the coaches, it was Behavioral CQ. Rankings for CQ dimensions among the participants were as follows: Motivational CQ, followed by Metacognitive CQ, Cognitive CQ, and finally Behavioral CQ. Regarding CQ stages, both athletes and coaches perceived CQ Drive as the most important element when interacting in English. It was due to the interest, resilience, and openness required to overcome cultural barriers, build trust, and foster positive relationships with individuals from various backgrounds. The study suggests that the dimensions and stages of CQ contribute to enhancing intercultural communication effectiveness which could foster inclusivity in contexts where English is the medium of communication or in cross-cultural setting.

INTRODUCTION

Communication in team sports is significant in building team dynamics, especially in an international sport team. Communication in an international sport team consists of multicultural athletes and multicultural coaches in a cross-cultural environment through the process of transmitting information, ideas, thoughts, and emotions between individuals or groups through verbal, non-verbal, or written means [1]. To build trust, improve teamwork and ensure effective interaction and clarity between multicultural athletes and multicultural coaches in cross-cultural environment cultural intelligence (CQ) is implemented [2]. The medium of communication used in an international sport team by multicultural athletes and multicultural coaches is English.

With previous studies of cultural intelligence focusing mostly on business negotiation [3] and English instruction

in High school [4] in a cross-cultural environment. There has been little research conducted on cultural intelligence on multicultural athletes and multicultural coaches in a cross-cultural setting which are heavily required to navigate and manage cross-cultural difference towards more inclusive and diverse environments [28]. This study aims to fill this research gap by exploring the issues of the dimensions and stages of cultural intelligence alongside the framework of Kachru's three-concentric circles (1985) and how it affects interaction among multicultural athletes and multicultural coaches. Although multicultural coaches are commonly trained in several aspects of the game as well in different disciplines, to our knowledge they rarely receive training on cultural intelligence.

Cultural intelligence is the capability of a person to adapt effectively to different cultures [5]. Cultural Intelligence in Sport focuses on the cultural factors that contribute

to athletic performance and multicultural athletes' well-being introducing cultural strategies to be implemented in the sports context. A raised awareness of cultural factors is important because of the increased globalization resulting from multicultural coaches' and multicultural athletes' migration across countries and clubs [6]. Cultural intelligence has four dimensions: cognitive CQ, metacognitive CQ, motivational CQ, and behavioral CQ [5]. Cognitive CQ is the understanding of the cultural systems, cultural values, language, and leadership. Metacognitive CQ is described as the awareness, planning, and checking assumptions about different cultures. Motivational CQ is intrinsic or extrinsic interests and self-efficacy in interactions with people from different cultures. Behavioral CQ is the verbal, nonverbal, and speech adaptations in interactions involving people from different cultures.

The easiest way to equip multicultural athletes and multicultural coaches with cross-cultural skills is to develop the stages of CQ. The stages of CQ are: CQ drive, CQ knowledge, CQ strategy and CQ action. Each stage is essential for navigating cross-cultural interactions [6]. CQ drive reflects an individual's motivation and confidence in functioning in cross-cultural settings. CQ knowledge is the level of understanding cross-cultural customs, practices and traditional conventions. CQ strategy is the planning and interpretation process involved in a cross-cultural interaction. CQ action is the adaptation of verbal and non-verbal behavior when interacting in a cross-cultural setting.

This study had two main objectives which are:

1. To examine the dimensions of cultural intelligence of multicultural sport coaches and multicultural sport athletes when they communicate in English.
2. To investigate the stages of cultural intelligence of multicultural sport coaches and multicultural sport athletes when they communicate in English.

This study had two main research questions that needed to be answered which are:

To what extent do multicultural sport coaches and multicultural sport athletes exhibit cultural intelligence when they communicate in English?

1. Based on R1, what are the stages of cultural intelligence of multicultural sport coaches and multicultural sport athletes when they communicate in English?

The findings of the present study would be beneficial to

readers in two ways. Firstly, the results in this research may become a guideline to help multicultural athletes and coaches to become aware of how to interact effectively in English in the contexts such as coaching or practices. Secondly, the findings may be used as examples for those teaching and studying subjects related to English as a global lingua franca or cultural communication.

LITERATURE REVIEW

Cultural intelligence (CQ) can be defined as "having what it takes" [22] to successfully integrate and survive in another culture. [11], enumerated four dimensions of cultural intelligence that are contingent upon adjustment in culturally diverse situations. The cognitive, metacognitive and motivational dimensions are psychological aspects while the behavioral dimension is situational [17]. CQ has emerged as the vital concept in understanding and improving cross-cultural interactions [21]. The process of applying these capabilities in real-world cross-cultural interactions is referred to as the stages of CQ. The four stages of CQ are: CQ drive, CQ knowledge, CQ strategy and CQ action. Each stage is essential for navigating cross-cultural interactions and the steps required to apply CQ in real life situations.

A. Cognitive CQ

Cognitive CQ relates to the comprehension of different cultural customs, values, and beliefs. Cognitive CQ refers to the person's knowledge structures and their consistent use the knowledge to understand the underlying reasons behind different cross-cultural behaviors and how to interpret accurately [11]. Based on Cognitive CQ, Cross-cultural knowledge influences people's beliefs and behaviors, hence, contributes to cognitive CQ. So, individuals that exhibit high cognitive CQ demonstrate an enhanced capability to modify their thinking patterns and responses to meet the demands of various cross-cultural contexts. This proficiency in understanding cross-cultural nuances fosters effective communication, collaboration, and decision-making across cultures [5].

B. Metacognitive CQ

Metacognitive CQ is the acquisition of higher-order mental processes and knowledge that assist in noticing the cultural preference of others [12]. Metacognitive CQ is the awareness and comprehension of one's cultural practices and prejudices, alongside the ability observe and modify cognitive processes in various cross-cultural

situations. [11]. It involves planning and monitoring cross-cultural understanding. Individuals with high metacognitive CQ show more flexibility and success in multicultural situations such as adjusting your tone or approach when communicating in a cross-cultural environment [5]. Recognizing and reflecting on their cultural prejudices and assumptions allow them to reduce misunderstandings, improve communication, and create relationships with individuals from diverse cultures [11].

C. Motivational CQ

Motivational CQ is a critical factor in assessing one's interest to engage with diverse cultural contexts effectively [11]. Motivational CQ is a key determinant of an individuals' success such as fostering intrinsic motivation, interest, and confidence in engaging with diverse cultures when interacting. Individuals with high motivational CQ demonstrate greater resilience, openness, and adaptability in cross-cultural interactions [5]. The intrinsic motivation to engage with individuals from diverse cultures enables one to overcome cultural barriers, build trust, and foster positive relationships with individuals from various backgrounds.

D. Behavioral CQ

Behavioral CQ is the manifestations of the right and flexible verbal and non-verbal behaviors such as words, tone of voice, gestures and facial expressions and actions during cross-cultural interactions [16]. Behavioral CQ is critical to an individual success in cross-cultural interactions which can improve their intercultural effectiveness and develop healthy interactions across cultures by studying and changing their behaviors to match with other interactants cultural norms and expectations [17]. Individuals with high Behavioral CQ perform better in cross-cultural communication and teamwork [5].

E. CQ Drive

CQ drive reflects to an individual's motivation and confidence in functioning in cross-cultural settings [11]. CQ drive also assesses the degree of confidence in adapting towards new cultures and interactions with individuals from different cross-cultures. CQ suggests that individuals with high CQ drive positively influences an individual's persistence and resilience in cross-cultural situations which leads to more effective communication and collaboration [5].

F. CQ Knowledge

CQ knowledge refers to the level of understanding cross-cultural customs, practices and traditional conventions [11]. Having general knowledge about a culture consists of recognizing apparent customs, guidelines, practices, languages, and modes of interaction; physical structures such as economic models, legal frameworks, and societal hierarchies; as well as the unseen psychological aspects like assumptions, values, and belief systems.

G. CQ Strategy

CQ strategy comprises of planning, awareness and reflecting of cross-cultural interactions [11]. It also includes being aware of cultural dynamics and making adjustment to perceptions and assumptions when communicating in a cross-cultural setting. Individuals with strong CQ strategy can avoid stereotyping and keep an open mindset in all your interactions, making it easier to respond appropriately to complex cross-cultural situations [5].

H. CQ Action

CQ action involves the modification of verbal and nonverbal communication like gestures, tone or language to facilitate the cross-cultural expectation of others [11]. CQ action allows individuals to be more flexible and responsive, thus enhancing their ability to build rapport and mutual understanding with people from diverse cultural origins [5].

METHODOLOGY

A. Participants

The participants of this research were multicultural athletes ranging from 18–50 years old and multicultural coaches from 23 years which represented the total of 25 multicultural athletes, and the total of 8 multicultural coaches. A total of 33 questionnaires were distributed among the participants. The participants were grouped into Kachru's three concentric circle which consists of inner circle (5 participants of American and Canadian), outer circle (16 participants of Indian, Nigerian, Malian, Philippines, Trinidad and Tobago and Zambian) and expanding circle (12

participants of Thai). A total of 33 (30 men and 3 women) participants took part and their data were validated and considered for data analysis. This study employed a quantitative method with the use of means using the Cultural Intelligence Scale (CIS) questionnaire developed by Earley and Ang (2003) [5] to examine the perspectives of both multicultural athletes and multicultural coaches who were grouped based on the use of Kachru's Three-concentric circle framework. The study was approved by the Ethics Committee of Srinakharinwirot University (SWUEC-672486).

RESEARCH INSTRUMENTS

The online survey included the Cultural Intelligence Scale (CIS) Questionnaire developed by Early and Ang [5]. All questionnaires used a Likert scale from 1 to 7 (1 = strongly disagree, 7 = strongly agree). The CIS Questionnaire was developed primarily for this study based on the CIS Questionnaire by Early and Ang [5]. I adopted the questions to include the context "I the coach or I the athlete" in the beginning of every questions. The respondents were asked to rate if the item in the questionnaire pertains to their strategic, knowledge, behavioral and motivational dimensions of cultural intelligence, with higher scores indicating positive responses. The mean scores varied from 4.34 to 6.25, thus exceeding the midpoint of 4.00 for all dimensions of cultural intelligence.

RESULTS

With the results, the overall sampling group was collected and analyzed based on the results from the questionnaire. The sampling group were divided into two groups to determine the dimensions of CQ. To investigate the dimensions of CQ, mean variables were used to calculate the dimensions of CQ of both groups.

To test the hypothesis of the CQ stages, the use of composite CQ score was implemented based on the results of the CQ dimensions, the average overall score of the dimensions was used to get the overall CQ score. The statistics were used to determine the statistical significances of the CQ stages of the multicultural athletes and multicultural coaches.

DISCUSSION

A closer look at the CQ dimensions and stages of multicultural athletes and multicultural coaches when interacting answered the first research question which stated that "to what extent do multicultural sport coaches and multicultural sport athletes exhibit cultural intelligence when they communicate in English?". Table I and table II indicated that both multicultural athletes and multicultural coaches had the highest CQ dimension Motivational CQ. This dimension of CQ for both sample groups is prevalent with the highest dimension (Mean = 6.25) which falls on the range of 6.01–7.00 (Very Strongly Agree). The results also correlate with Early and Ang (2003) [5] that states

that persons with high Motivational CQ demonstrate greater resilience, openness and adaptability in cross-cultural interactions. Therefore, multicultural athletes and multicultural coaches will demonstrate high interest and confidence when interacting in English in a cross-cultural setting.

With the second highest CQ dimensions of multicultural athletes (Mean=5.75) and multicultural coaches (Mean=5.32) with a difference of 0.43 between them. With the results, both fall under the range of 5.01–6.00 (Strongly Agree). The results correspond with Early and Ang (2003) [5] that states individual with high metacognitive CQ demonstrates more flexibility and recognizing cross-cultural assumptions and prejudices when interacting in English in a cross-cultural context.

In regards to behavioral CQ, multicultural athletes had behavioral CQ (Mean=5.72) has the third CQ dimension while multicultural coaches had behavioral CQ (Mean=4.34) has the lowest dimension. With this results, multicultural athletes (Mean=5.72) falls under the range of 5.01–6.00 (Strongly Agree) which also aligns with Early and Ang (2003) [5] which states that when using proper verbal and nonverbal actions when communicating English, persons with high behavioral CQ perform better in cross-cultural communication. For multicultural coaches (Mean=4.34) has the lowest CQ dimension falls in the range of 4.01–5.00 (Agree) which corresponds with Early and Ang [5] that states persons with low behavioral CQ might demonstrates misinterpretation of communication styles such as gestures, expressions or tone that may be inappropriate or offensive when communicating in English in a cross-cultural interaction.

In regard to cognitive CQ, multicultural athletes (Mean=4.86) has the lowest CQ dimension while multicultural coaches (Mean=4.78) has the cognitive CQ has the third dimension. With multicultural athletes (Mean 4.86) falling in the range of 4.00–5.00 (Agree), it correlates with Early and Ang (2003) [5] that indicates individuals with low cognitive CQ lack contextual knowledge and mis underlying cultural meanings in communication that leads to misunderstanding of cultural references when interacting in English in a cross-cultural setting. For multicultural coaches (Mean=4.78) which falls under the range of 4.01–5.00 (Agree), it corresponds with Early and Ang (2003) [5] that states individuals with slightly high Cognitive CQ tend to understand cross-cultural norms and

differences but their inability to respond appropriately may cause miscommunication in English.

Pertaining to the second research question stating, “what are the stages of cultural intelligence of multicultural sport coaches and multicultural sport athletes when they communicate in English?” The results on table III and table IV showed multicultural athletes and multicultural coaches had the highest CQ stage in CQ Drive. CQ Drive of both multicultural athletes (Mean=1.345) and multicultural coaches (Mean=2.035) had the highest numerical data indicating a CQ Drive has the highest CQ stage which corresponds to Early and Ang (2003) [5] stated that persons with high CQ Drive positively influences an individual’s persistence and resilience in cross-cultural situations, which leads to more effective communication in English and collaboration.

In the case of CQ Knowledge, multicultural athletes (Mean=1.136) was the third CQ stage alongside multicultural coaches (Mean=1.707). The results placed them at the same CQ stage and did not differ also corresponding to Early and Ang [5] stating that individuals with high CQ Knowledge can reduce misunderstandings by helping individuals recognize cross-cultural differences and adapt accordingly when interacting in English.

For CQ strategy, multicultural athletes (Mean=1.301) was the second highest CQ stage while multicultural coaches (Mean=1.623) had the lowest CQ stage. With this result correlating with Early and Ang (2003) [5] stating that individuals with strong CQ Strategy can avoid stereotyping and maintain a flexible and unbiased attitude during every interaction, making it easier to respond appropriately to complex cross-cultural situations. In contrast to multicultural coaches that indicated the lowest CQ stage might be the result of different age, era and generation of society they are born and grew up.

For CQ Action, multicultural athletes (Mean=1.114) had the lowest CQ stage while multicultural coaches (Mean=2.021) had the second highest CQ stage. In the case of multicultural coaches corresponding with Early and Ang (2003) [5] stating that high CQ Action allows individuals to be more flexible and responsive, thus enhancing their ability to build rapport and mutual understanding with people from different cross-cultural backgrounds. This result correlates why multicultural coaches are more observant with verbal and nonverbal behaviors when interacting in English unlike multicultural athletes who are less observant.

The overall findings of this research indicates that both multicultural athletes and multicultural coaches take motivational CQ has the highest CQ dimension which also correlates with CQ drive as the most important CQ stage due to the degree to the degree of interest, persistence and confidence needed in communicating in English during cross-cultural interaction. It also shows the high or low level of interest taken when communicating in English. In terms of multicultural athletes, the lowest stage CQ Action has less ability to interact and perform well in culturally diverse scenarios while for multicultural coaches, the lowest stage CQ Strategy indicates a low ability and awareness to plan for cross-cultural interactions.

CONCLUSION

The research findings are crucial and helpful for both multicultural athletes and multicultural coaches to be aware of how to interact effectively in English in different contexts such as coaching and practicing it their respectful sport. Further research can be implemented in this research due to the low number of participants. With a higher sampling size, each dimension and stages of CQ can be discussed and explored more with the framework of Kachru's three-concentric circle.

Expanding research on cultural intelligence could provide more details and analysis in business negotiation, training services as the base to develop this study for future research. This helps to understand and investigate between foreigners and locals and also relevant in understanding business negotiation in a cross-cultural setting. Furthermore, qualitative study can be implemented such as focus groups or individual interviews which could help derive more meaningful insights into the differences between high and low CQ across the various Kachru's three-concentric circles. It will also help breakdown each circle and how it affects English communication between multicultural athletes and multicultural coaches.

This case study establishes a significant relationship between PBL and Collaborative Learning (CL) [3]. The proposed PBL opted for Pulse and digital circuits as a case study. The reason behind selecting this course is that most of this course content is relevant to integrated circuits, which are most frequently used in intelligent electronic controlled projects. The IC555, IC741 and, IC565, IC566 are frequently used in many electronic-based projects [4][5]. If the students understand the concept, its application and analysis will become simple.

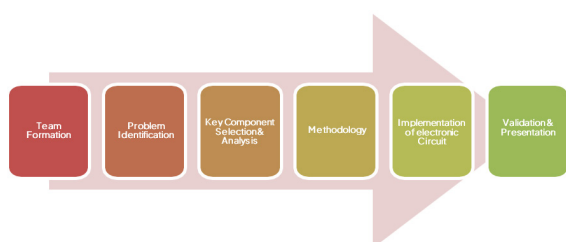


Figure 1. Proposed PBL Execution Stages

The following Fig.1 describes the execution steps of the Project-based Learning (PBL) case study.

PBL PROCESS FLOW

Step 1. The team is initialized as a group of three members. The teams are categorized into groups with different learners.

Step 2. Each group will identify the problem in the relevant course contents and list the issues and challenges in the course domain.

Step 3. Identify relevant components from the course content that can be applied as the central part of the circuit design, like a controller. So, they must understand the characteristics and analyze the functionality under various circumstances.

Step 4. The students will collaboratively think about how the

identified component can be used to rectify the problem statement.

Step 6. Finally, the circuit should collect all the remaining components and make the connections.

Step 7. The circuit and the final project report documentation should be tested in real time.

During the initial phase, the PBL implementation started with essential knowledge sharing on the functionality of ICs and their graphical representation and pin descriptions. In the second phase, video lectures were given to enhance their understanding [6]. In the final phase, we asked them to identify problem statements where we could solve them using the learning concepts.

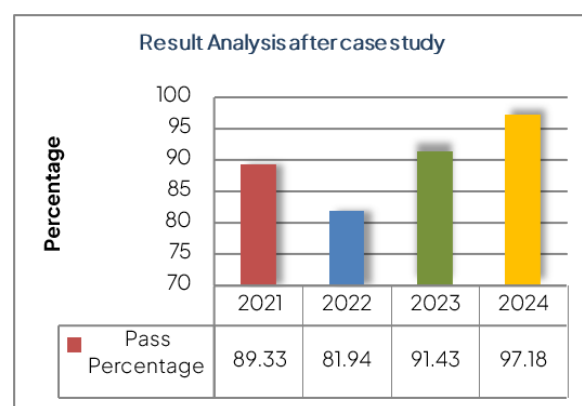


Figure 2. Result Analysis of Without PBL (2021–2022) and with PBL (2024)

The analysis was carried out from 2021 to 2024. As shown in Fig.2, in 2023 and 2024, after implementing PBL, almost a 10% pass percentage was increased. Implementation of PBL started in 2023. Still, after facing challenges and solving issues like understanding the students' points of view after feedback and suggestions in 2024, PBL was successfully implemented and achieved an excellent outcome. SUMMARY

This study aims to elevate the impact of project-based learning and outcomes after implementing it in the classroom. Nowadays, so many online platforms are available for learning, so traditional blackboard learning may not be sufficient for better understanding. Practicality is essential in the present education system to sustain in the competitive world. The students are losing experimental and logical learning in the present education scenario.

From the last academic year, project-based learning has been actively implemented in the selected subjects. The students are actively engaged in the PBL learning; by this learning, the students improved in certain areas, specifically the use of collaboration, technology tools, complex problem analysis and presentation skills [7][8]. After implementing project-based learning, all the performance observations are tabulated by considering various characteristics like group and individual performance in seminars, project output and performance in internal and external assessments, and student feedback.

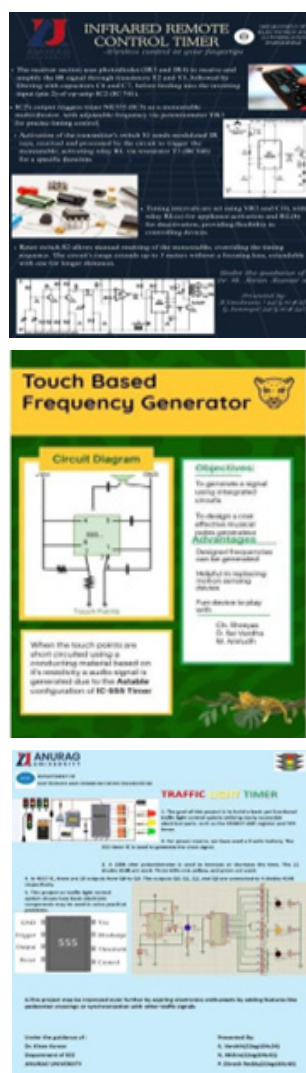


Figure 3. Sample Student project works under PBL

After implementing PBL for the course Pulse and Integrated Circuits, they observed fantastic results in their internal assessment exams.

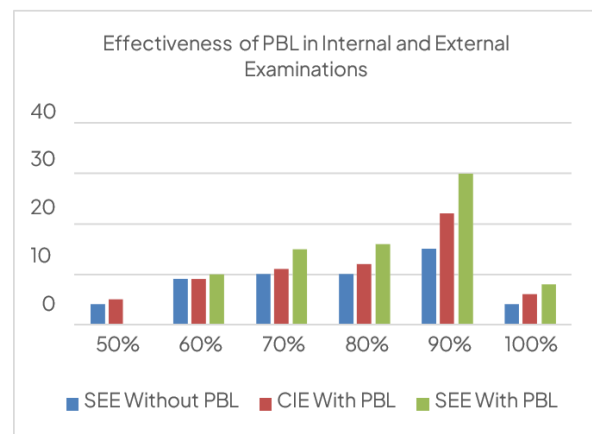


Figure 4. Effectiveness of PBL in Internal and External Examinations

They also performed well in the internal continuous examinations. The performance analysis shown in Fig.4 The following Fig.4 shows the effectiveness of PBL in Continuous internal examinations(CIE) and Semester end examinations(SEE). We can notice that with PBL learning, the students show better results than with regular traditional learning.

Extensive scholarly efforts have been devoted to understanding the origins, nature, applications, and future development of AI. The emergence of AI as a scientific discipline is influenced by a variety of fields, including mathematics, physics, biology, physiology, biotechnology, computer science, psychology, philosophy, logic, linguistics, and economics. One of AI's most crucial areas is natural language processing, which is central to the development of AI-generated electronic dictionaries. As is well-known, the areas of formal text analysis, natural language processing, machine translation, data retrieval based on formal characteristics, linguistic research using mathematical and statistical methods, the compilation of statistical dictionaries, and the development of electronic dictionaries are all considered integral to the field of computer linguistics, as well as corpus linguistics. Corpus linguistics specifically focuses on the creation of information retrieval systems designed to collect texts

that represent a specific language in electronic format and utilize them for research purposes. It is my belief that the issues surrounding computer and corpus linguistics are intrinsically linked to the broader challenges of artificial intelligence, and it would be more appropriate to examine them within this context.

Artificial intelligence represents the science and technology of creating intelligent systems smart machines, particularly computer programs capable of performing creative functions traditionally associated with human

cognitive abilities. The term “intelligent system” refers to a technology or software system that, by storing information in its memory, can solve problems typically characterized as requiring creativity. Numerous studies have been conducted, and extensive literature has been produced, exploring the history, essence, significance, and future prospects of artificial intelligence.

Indeed, artificial intelligence has emerged as an independent scientific discipline, born at the intersection of various fields of study. The primary objective of AI is to develop systems that can emulate human cognition, thought processes, and brain functions. The development of AI as a scientific field incorporates methodologies, techniques, and tools from virtually all branches of science, utilizing both the latest advancements and well-established approaches. Additionally, AI’s application is underpinned by the integration of both scientific and engineering technologies. The term “artificial intelligence” was first coined in 1956 by John McCarthy, who defined it as the science and engineering of making machines capable of exhibiting intelligent behavior [McCarthy, J, 1990].

The characteristics that define artificial intelligence (AI) include the following:

- The formulation and resolution of specific problems related to modeling human activity, which is considered intellectual in nature.
- The development of technology or software systems capable of storing knowledge in memory and solving creative problems related to specific subject areas.
- The creation and implementation of software systems that address complex issues through self-learning programs, primarily via heuristic approaches.

In a notable interview, the American entrepreneur Elon Musk acknowledged the significant potential of AI while also highlighting the potential risks it poses to humanity. Similar to how nuclear energy can be harnessed for peaceful purposes or for destructive means, AI, too, could be used for both beneficial and harmful ends. It is hoped that the scientific community will direct the development of AI in a way that benefits humanity.

A key question arises: Are computers capable of human-level development and activity? In 1950, the English scientist Alan Turing published his article “Computing Machinery and Intelligence”, in which he introduced a novel approach that would later become known as the “Turing Test” [Atkin,

2008]. The standard interpretation of the test is as follows: A computer and a human engage in a conversation, and based on their responses, the participant should be able to determine whether they are interacting with a computer program or a human. The computer’s task is to deceive the participant, making it difficult to distinguish between the two. The participants do not see each other during the interaction.

It is important to note that the processing of natural text, data retrieval based on formal characteristics, machine translation, statistical lexicography, formal linguistic analysis, the compilation of electronic dictionaries for various purposes, and the use of mathematical and statistical methods to analyze linguistic data are all areas of research within both corpus linguistics and AI systems.

As early as 1985, French linguist Loffier Lorian urged translators to adopt computer-assisted translation, stating: “If online services like Systran (www.systranet.com) and Weidner (en.m.wikipedia.org/wiki/weidner_communication) are used, we will have to do a great deal of editing on the translated text” [Newmark P, 1987].

Systran is one of the oldest and most successful machine translation systems. Initially developed by the American company SYSTRAN for the US Air Force in 1968, it was originally created as a Russian-to-English translator. By 1973, an English-to-Russian translation system was added, specifically for the Soviet-US Apollo space project. Logos and OpenLogos (US and Germany) also emerged in 1972. In 1996, AltaVista Babelfish introduced machine translation for small text segments, which later evolved into Google Translate under the leadership of Franz-Josef Och in 2003.

For over five decades, SYSTRAN has maintained a leading position in machine translation. The company has become a trusted provider of translation capabilities across a range of industries, including finance, law, security, software, and mobile devices. Its influence on technology and culture has been profound, and it continues to innovate with the launch of new, tailored solutions for diverse industries. Peter Tom, the company’s founder, expressed his vision: “I felt that I should dedicate my efforts to eliminating the factors that cause conflict in the world. By addressing the language barrier, I believe I can help bridge understanding across cultures” [Newmark P, 1987]. In the near future, SYSTRAN plans to release a new generation of systems that will offer customized solutions designed to meet the linguistic needs of specific domains and enterprises [www.

systrosoft.com].

Azerbaijani scientist Lutfi Zadeh's theory of fuzzy logic is considered a groundbreaking contribution to global science. Zadeh is also credited with developing the "Theory of Impressions," the "Theory of Systems," the "Theory of Word-Working Computers," and the "Theory of Optimal Filters," all of which have played a pivotal role in shaping modern scientific foundations. The creation and application of advanced linguistic technologies are at the core of artificial intelligence systems. It is impossible to envision the robotics industry without them. Robots capable of understanding speech, responding to specific questions, and executing verbal and written commands rely heavily on natural language processing technologies.

Some robots created in the framework of artificial intelligence:

- Pepper (robot) - put on sale by Japanese companies since 2015. What makes this humanoid robot different from other robots is that it has emotions. He can understand people's moods by their facial expressions, he has access to the Internet to search for the answers he needs;
- Watson — a robot that understands human speech and has the ability to perform probabilistic searches in the field of numerous algorithms is an advanced development system of the IBM company;
- ChatMaster - virtual chat programs is a computer program that imitates human speech and chats with one or more people;
- Deep Blue - Developed by IBM. Specialized in chess games;
- MYCIN is considered a system capable of accurately diagnosing a small number of diseases at the human-doctor level;
- Speech recognition - ViaVoice type systems are able to meet the needs of users;
- Voice (speech) to text, text (printed text) to speech systems are currently widely used for various purposes.

A lot of work is being done in this direction in Azerbaijan. Speaking about the achievements of linguistics, it is impossible not to mention prof. M.A. Mahmudov's work "Computer Linguistics". It should be noted that "Electronic computing machines in linguistics" by V.Y. Pines and M.A. Mahmudov, "Automatic syntactic analysis and synthesis of text" by K.A. Valiyeva, "Automatic editing of texts",

“Statistical analysis of Kitabi-Dade Gorgud epics” and other research works should be considered one of the achievements of electronic linguistics. The algorithmic solution of verb ambiguity in the English-Azerbaijani machine translation system is at the center of A.A. Aliyev’s research [Mahmudov, 2013].

Experiments prove that the wide connection of linguistics with other fields of science is one of the main reasons for its rapid development.

Already, the development in this field shows that modern computer linguistics is able to overcome the controversial problems existing in traditional linguistics. It is one of the main predictions of linguists that there will be more progressive events in this field in the near future.

It should also be noted that in recent years, as a result of the wide application of information technologies to all fields of science, applied informatics departments have been formed and society has gradually started to benefit from this.

Modern linguistics conducts continuous research on the study of the advantages of electronic dictionaries and their further development in the future. Recently, linguists have turned to electronic dictionaries due to the emergence of a large number of electronic dictionaries on the Internet and the increase in the number of uses. Electronic dictionaries are types of dictionaries arranged in alphabetical order and consisting of innovative search techniques. These types of dictionaries are more portable and easily accessible, most of them are free and constantly updated. If we look at the principles of the dictionary, the step-by-step explanation of the presentation of words in electronic dictionaries can be as follows:

1. Dictionary article – statement of the meaning of the word, definition
2. Thesaurus – a tool used to find synonyms and antonyms of words
3. Pronunciation – pronunciation of the word
4. Translation – The process of converting words from one language to another
5. Spell checker – A tool used to check the spelling of words
6. Search function – a tool used to find specific words or phrases in the electronic dictionary (wild card, drop-list functions)
7. Word of the day – A function that shows a new word and its explanation every day
8. User interface – Visual design and functionality of the electronic dictionary
9. Voice recognition – A feature that allows users to pronounce a word and provide its explanation in the dictionary
10. Offline use – the ability to use the electronic dictionary without an Internet connection.

P. Newmark noted: “Works on electronic dictionaries should be further improved so that the development provides a direct result to the user, that is, rapid information translation and publication translation together” [Newmark, 1987].

When using computer translation, the translator has two versions of the text:

- Fast information translation (this can be a draft text; it can differ from a live brain product);
- Publication translation (this may be a product of the human brain).

10. Etymology - the explanation of the roots of words and their evolution over time, the study of the origin, etymology and history of words;

Electronic encyclopedias are considered one of the most important components in the network of computer dictionaries. Electronic encyclopedia hyperlinks and references can be found during a search in some dictionaries active on the Internet.
